
The Inspector: Once a highly respected Police Officer, The Inspector was thrown from his beloved job following the disappearance of Amy Haven. He thought he 'had his man', and broke the rules to prove it. The newspapers destroyed the old man, who has felt haunted by Amy ever since. This Bonfire Night he is determined to find out what really happened to her.


Amy Haven: The young girl disappeared on her 11th Birthday, after being expelled from school. The Head Mistress of Saint Swithin's School for Girls thought her a bad influence on the other girls, and she frightened her teachers with macabre drawings and an unhealthy interest in the dead! Amy then vanished, never to be seen again...until Bonfire Night, when The Inspector goes looking for her.

**Mr.Bones:** No-one knows the real identity of this dark minded vagrant. Mr.Bones is so named after his appalling habit of collecting road kill, skinning the rotten carcass and them boiling the flesh from the bones. Mr.Bones believes he can communicate with the dead, using bones for divination, an ancient art thought to have perished with the 'Old Ones'. Amy shared Mr.Bones fascination for the paranormal, so joined his practise shortly before she disappeared. Mr.Bones definitely knows more about Missing Amy than he is likely to tell.

**Echo:** This eerie character communicates with you through mobile phone text messages (SMS). They appear to be helping you uncover the mysterious behind the Dark Fall, but may have an agenda all of their own. Leading you from one dark experience to the next may suggest that Echo is not as friendly as they first seem.

Life Leech: A vile, stinking creature that lives off souls in torment. Like a parasite, it is utterly dependent on a host, a ghost trapped in purgatory. The leech feeds and lives by consuming the negative energy created when somebody dies prematurely, and is unable to 'move on'. Only by successfully calling up a spirit, or ghost, will you be able to see the Life Leech itself. It is a precious moment, and all too brief, given that you must destroy the leech, with a weapon, to 'free' the ghost and communicate with them. Beware, the Life Leech can spit health threatening poisons, from an orifice on it's body. Destroy them guickly, and efficiently.





The Forgotten: A ghost, or spirit, of someone unable to 'pass on', and enter the afterlife. A member of the 'Forgotten' have usually made some terrible decision, at the last moments of their life, which causes a disturbance in time, and a Life Leech is created to eat the negative energy left behind. A ghost can be summoned by presenting the correct offerings; they are usually a portrait of the subject, a 'trigger item' and a 'power item' (see Summoning Ghosts for further details). After summoning, you will have an opportunity to converse with the spirit. Be warned, some ghosts may be confused or not recognise where they are, due to being trapped in purgatory for decades. They may even forget who they are, or what it was that they did that brought about their demise.

Shadowkin: Half-formed ghosts and spirits who are cursed to wander the earth seeking the warmth and light of the living. Never, ever, stay in a darkened space if you suspect the Shadowkin are present, as they will gather around you and drain away your life. Shadowkin are especially prevalent near Life Leeches, as the two species consume the same matter, that being the lost and wasted lives of the living. If you find yourself surrounded by Shadowkin, quickly perform any acts you must, or leave the location as quickly as possible. Those attacked by Shadowkin will recover over time, or, if you dwell too long, you will be consumed.

**Regrets:** A regret is a place in time and space where somebody made the 'wrong' decision. It is something they would always regret, possibly leading to their own demise. You will have a chance to enter the 'regrets', of The Forgotten, and change the outcome of the wretched souls. Learning as much as possible, you will gain the trust of The Forgotten, and help them move on, into the afterlife.

## HOW TO PLAY

The world of Dark Fall requires exploration and experimentation. The cursors are your guide to what can be accomplished and where you can go.



#### Forward:

Click to proceed into that area.



#### Turn Right, Turn Left: Do a complete 90-degree turn in the chosen direction.



#### Look at:

You will either turn to face your subject, or cut to a closer view.

#### Drag or Pull Item:

Occasionally a barrier may need to be 'pulled' out of the way, to proceed further. Or, an item may need to be 'pulled' from its hiding place. Click the cursor on the item, and drag in the direction indicated.

## MAIN ITEMS

You have two very important items, stashed in your inventory for the majority of your adventure. They are:

#### Phone:

This handy mobile phone will prove to be a lifesaver, literally, in times of need. The phone is able to receive text messages (SMS) from Echo, your mysterious informant, and provide Nite-Vision sight in very dark places, such as the woods. The mobile also allows you to Save and Load your progress through the game, see 'Saving and Loading'.

#### Scissors:

A lethal weapon, in the right hands, the rusty scissors will need to be found early on in the game, if you are to proceed. Be warned, the scissors are rusty through lack of use, and decades of dereliction, so they are likely to break if used brutally, or repeatedly. If this happens, return to a Scissor Stash, and collect a newer pair. The scissors are useful for breaking open containers, old locks, rotten doors, crumbling walls and, of course, you can destroy Life Leeches! See Life Leech in the 'Meet the Characters' section.

## SAVING AND LOADING

#### Saving your progress:

Once The Inspector's Mobile Phone is active you can save and load at any time during the game.

#### To Save:



Click the Mobile Phone, in the bottom left corner, of the screen. It will become active. Then, click the 'Save' Icon. Use the forward and back arrows to scroll through your Save slots, and select an empty one, if making a new save, or select an old save to 'overwrite'.

To Load:

Click the Mobile Phone, in the bottom left corner, of the screen. It will become active. Then, click the 'Load' Icon. Use the forward and back arrows to scroll through your Load slots, and select one of your previous saves. Your last Save Game will have the most recent time and date.
